Subject: FIR against theft of electricity.

Dear Sir,

I do hereby lodge this written complaint empowered by the electricity act 2003 read with amendment act 2007 to the effect that one Sri Sibaprasad Ghata, S/O: Lt. Kenaram Ghata of Village : Kunjaberia, P.O : Bulakipur P.S.: Patashpur, Dist. : Purba Medinipur has committed theft of electricity under section 135(i)(a) of the electricity act 2003 with amendment act 2007 as stated hereunder.

On 20.01.2017 at about 1.30 pm I, Aniruddha Hazra, AE & SM, Patashpur CCC along with Sri Arunangshu Mondal, SAE (E), Patashpur CCC, Sri Trilochan Bagdi, Hg. Sr. TSH, Patashpur CCC & others went to inspect the agricultural premises with consumer id 201956452 & meter no GX025893 at Kunjaberia mouza as a part of supervisory meter reading checking program and found that said consumer Sri Sibaprasad Ghata, S/O: Lt. Kenaram Ghata was consuming electricity dishonestly by means of direct hooking from nearby distribution transformer's LT bushing side to run another separate installation of STW motor of a tune of load 5 HP beside the said legal service connection holding consumer id 201956452 with 2 no separate blue coloured & one no separate yellow coloured 7/16 SWG PVC coated aluminum wire illegally to run another second STW motor of 5 HP load for agricultural purpose for his wrongful gain causing considerable loss of revenue and energy of WBSEDCL.

As theft of electricity was detected, said 3 separate PVC coated wire used for direct hooking was disconnected from the electrical live network and some portion of the said PVC coated wire (each approx. 3 meter) along with the hooking device was seized in presence of the witness and signature of the witness obtained on the seizure list. The seized article were duly packed and labeled at the inspection site and the signature of the witness obtained on the label. Sri Sibaprasad Ghata was present during inspection but refused to sign on the inspection report, seizure list and label. However another local cultivator Sri Joydev Maity, S/O : Sri Ananta Maity of the same village Kunjaberia was present during the inspection and acknowledged the full proceedings by putting his signature on inspection report, seizure list and label at the site. The inspection team left the aforesaid premises at about 2.10 pm.

The accused Sibaprasad Ghata, S/O: Lt. Kenaram Ghata of Village : Kunjaberia, P.O : Bulakipur P.S.: Patashpur, Dist. : Purba Medinipur has committed theft of electricity under section 135(i)(a) of electricity act 2003 with amendment act 2007.

You are hereby requested to take cognizance of this offence and treat this complaint as FIR.
