Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Pulin Behari Maity, S/O - Sri Debendranath Maity, a permanent resident of Vill- & P.O -Pania, P.S -Patashpur, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 16.06.2017 at about 01:30 PM I, Sri Manas Maity, A.E.(U), Sri Pradip Kr Chakraborty, SO, both are of (S&LP) unit Contai Division Office along with Sri Aniruddha Hazra, AE & SM Patashpur CCC, Sri Bechan Prasad Barai, Hg. Sr. LM Patashpur CCC and others had been to the village- Pania for routine inspection purpose. During inspection it was found that Sri Pulin Behari Maity was consuming electricity dishonestly in his Domestic premises unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL through 2 (Two) number saperated single core blue colour PVC coated 1100/660 Volt grade 10 sq mm aluminium conductor causing considerable loss of revenue of WBSEDCL to the tune of load 4.68 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 2 (Two) number saperated single core blue colour PVC coated 1100/660 Volt grade 10 sq mm aluminium conductor of length 3 (Three) meter each approx along with hooking device used to run the electrical appliances for domestic purpose as a sa has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Sudha Santi Maity, S/O- Sri Debendranath Maity (Elder brother of Sri Pulin Behari Maity) acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 02:00 PM.

Thus the accused Sri Pulin Behari Maity, S/O - Sri Debendranath Maity, Vill - & P.O -Pania, P.S -Patashpur, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
