Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Debasish Das, S/O - Lt. Santosh Das, a permanent resident of Vill- & P.O -Pania, P.S -Patashpur, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 16.06.2017 at about 02:05 PM I, Sri Aniruddha Hazra, AE & SM Patashpur CCC along with Sri Bechan Prasad Barai, Hg. Sr. LM Patashpur CCC, Sri Sunil Kr. Bauri, Hg. Sr. LM Patashpur CCC and others had been to the village- Pania for routine inspection purpose. During inspection it was found that Sri Debasish Das was consuming electricity dishonestly in his Commercial premises unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL through 1 (one) number single core stranded black colour PVC coated 7/20 swg aluminium conductor causing considerable loss of revenue of WBSEDCL to the tune of load 1.17 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 1 (one) number single core stranded black colour PVC coated 7/20 swg aluminium conductor of length 3 (Three) meter approx along with hooking device used to run the electrical appliances for commercial purpose as a sample has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Smt. Sutapa Das W/O- Sri Debasish Das acknowledged the same by putting her signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 02:30 PM.

Thus the accused Sri Debasish Das, S/O - Lt. Santosh Das, Vill - Pania, P.O -Pania, , P.S -Patashpur, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
