I do hereby lodge this written complaint empowered by the electricity act 2003 read with amendment act 2007 to the effect that one Sri Sankar Mandal, S/O: Nitai Charan Mandal of Village: Nonakourda, P.O: Mustafapur P.S.: Patashpur, Dist.: Purba Medinipur has committed theft of electricity under section 135(i)(a) of the electricity act 2003 with amendment act 2007 as stated hereunder.

On 02.02.2017 at about 10.30 am I, Aniruddha Hazra , AE & SM, Patashpur CCC along with Sri Arunangshu Mondal, SAE (E), Patashpur CCC, Sri Bechan Prasad Barai, Hg. Sr. Linesman, Patashpur CCC & others went to inspect the agricultural premises at Nonakourda mouza as a part of supervisory meter reading checking program and found that said consumer Sri Sankar Mandal , S/O: Nitai Charan Mandal was consuming electricity dishonestly by means of direct hooking from nearby distribution transformer's LT bushing side to run one STW motor of a tune of load 2 HP with 2 no separate blue coloured 3/20 SWG PVC

coated aluminum wire illegally for agricultural purpose for his wrongful gain causing considerable loss of revenue and energy of WBSEDCL.

As theft of electricity was detected, said 2 separate PVC coated aluminum wire used for direct hooking was disconnected from the electrical live network and some portion of the said PVC coated wire (each approx. 3 meter) along with the hooking device was seized in presence of the witness and signature of the witness obtained on the seizure list.
