Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Sukumar Santra, S/O - Lt. Bishnupada Santra, a permanent resident of Vill-Uttar Selmabad, P.O -Selmabad, P.S -Patashpur, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 09.02.2017 at about 02:00 PM I, Sri Manas Maity, A.E.(U), Sri Pradip Kr. Chakraborty, SO, both are of (S&LP), Contai Division Office along with Sri Aniruddha Hazra, AE & SM Patashpur CCC, Sri Bechan Prasad Barai, Hg. Sr. LM Patashpur CCC and others had been to the village- Uttar Selmabad for routine inspection purpose. During inspection it was found that Sri Sukumar Santra was consuming electricity dishonestly in his Agricultural premises by way of direct hooking from the nearby LT mains of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 6.58 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 3 (three) nos separated single core 7/16 SWG, 1100/660 Volt grade with faded red, yellow and blue colour PVC coated aluminium conductor of length 2 (two) meter each (approx) along with hooking device used to run the electrical pump-motor set for agricultural purpose has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Sukumar Santra refused to put his signature in the Seizure List, Inspection Report and label also. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 02:30 PM.

Thus the accused Sri Sukumar Santra, S/O - Lt. Bishnupada Santra, Vill - Uttar Selmabad, P.O -Selmabad, , P.S -Patashpur, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
