Flence his offence is punishable U/S 46 A © of the Bengal Excise Act.

Accordingly the Country Spirit were seized from the said person namely Gurai Charan Shit (58) s.o. Lt Mangobinda Shit of vill – Kharan, Post- Bulakipur, P.S-Patashpur.
