Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Siddhartha Guchhait, S/O - Ajit Kr. Guchhait, of Vill-Chistipurvery, P.O -Barmakhal, P.S -Patashpur, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 22.03.2017 at about 01:30 PM I, Sri Manas Maity, A.E.(U), (S&LP), Contai Division Office along with Sri Aniruddha Hazra, AE & SM Patashpur CCC, Sri Bechan Prasad Barai, Hg. Sr. LM Patashpur CCC and others had been to the village- Chistipurvery for routine inspection purpose. During inspection it was found that Sri Siddhartha Guchhait was consuming electricity dishonestly in his Agricultural premises by the way of direct hooking from the nearby LT mains (LT bushing of Distribution Transformer) of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 4.380 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 3 (three) number separated single core stranded 7/18 swg with Blue coloured PVC coated aluminium conductor of length 2 (two) meter each (approx) along with hooking device as a sample used to run the electrical Pump-motor (STW) set unauthorisedly has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Subrata Kr. Guchhait S/O- Ajit Kr. Guchhait acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 02:00 PM.

Thus the accused Sri Siddhartha Guchhait, S/O - Ajit Kr. Guchhait, Vill - Chistipurvery, P.O -Barmakhal, P.S -Patashpur, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003, read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
