Subject: FIR against theft of electricity.

Dear Sir,

I do hereby lodge this written complaint empowered by the electricity act 2003 read with amendment act 2007 to the effect that Jayanta Jana , S/O: Lt. Gopal Jana of Village + P.O : Gokulpur, P.S.: Patashpur, Dist. : Purba Medinipur has committed theft of electricity under section 135(i)(a) of the electricity act 2003 with amendment act 2007 as stated hereunder.

On 04.01.2017 at about 2.30 pm I, Aniruddha Hazra, AE & SM, Patashpur CCC along with Sri Sunil Kumar Bauri , Linesman, Patashpur CCC, Sri Trilochan Bagdi, Hg. Sr. TSH, Patashpur CCC & Sri Pradip Kumar Chakraborty, Special Officer, S&LP wing Contai Division and others went to inspect the commercial premises i.e. poultry farm situated at Gokulpur as a part of supervisory checking program and found that Jayanta Jana , S/O: Lt. Gopal Jana of the same village was engaged in unauthorized use of electricity at the said commercial premises by means of direct hooking from nearby LT overhead electrical source with black coloured 6 sq.mm. PVC coated cable illegally to run electrical appliance of a tune of load of 1 KW for commercial purpose for his wrongful gain causing considerable loss of revenue and energy of WBSEDCL.

As theft of electricity was detected, said PVC cable used for direct hooking was disconnected from the electrical live network and some portion of the said PVC black coated cable along with the hooking device was seized in presence of the witness and signature of the witness obtained on the seizure list. The seized article were duly packed and labeled at the inspection site and the signature of the witness obtained on the label. Sri Jayanta Jana was present during inspection but refused to sign on the inspection report, seizure list and label. The inspection team left the aforesaid premises at about 2.50 pm.

The accused Jayanta Jana , S/O: Lt. Gopal Jana of Village + P.O : Gokulpur, P.S.: Patashpur, Dist. : Purba Medinipur has committed theft of electricity under section 135(i)(a) of electricity act 2003 with amendment act 2007.

You are hereby requested to take cognizance of this offence and treat this complaint as FIR.
