Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Purnendu @ Purnendu Shekhar Pradhan, S/O- Lt. Jogendranath Pradhan of Vill: Kourmalsali, P.O- Ichabari, P.S-Patashpur, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 12.04.2017 at about 02:15 PM, I, Sri Aniruddha Hazra, AE & SM, Patashpur CCC, along with Sri Manas Maity, A.E.(U), Sri Pradip Kr Chakraborty, SO all are of [S&LP], Contai Division Office, Sri Arunangshu Mondal, SAE [E] Patashpur CCC and Sri Bechan Prasad Barai, Hg. Sr. LM Patashpur CCC and others had been to the Vill. Kourmalsali, P.S-Patashpur for routine inspection purpose. At first we went to the Industrial premises Sri Purnendu @ Purnendu Shekhar Pradhan, S/O- Lt. Jogendranath Pradhan of Vill: Kourmalsali, P.O- Ichabari, P.S-Patashpur, Dist-Purba Medinipur and during inspection it was found that Sri Purnendu @ Purnendu Shekhar Pradhan, S/O- Lt. Jogendranath Pradhan of Vill: Kourmalsali, P.S-Patashpur, Dist-Purba Medinipur consuming electricity unauthorisedly by way of hooking for making a loop connection for bypassing the energy consumption of the red phase of the 3 phase energy meter through single core with one joined white and black colour P.V.C coated 8 sq. mm. aluminium conductor in respect of Consumer Id No: 200264927, Meter No: LT509306, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and Some portion of two nos separated single core with one joined white and black colour another one black colour P.V.C coated 8 sq.mm. aluminium conductor of length 3 meter each approx along with hooking device used to run the electrical motor for industrial purpose unauthorisedly as a sample and one yellow card vide Sl. No- 0297774 in the name of Sri Purnendu Shekhar Pradhan were seized under memo of seizure list in presence of consumer and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 02:45 PM.

Thus Sri Purnendu @ Purnendu Shekhar Pradhan, S/O- Lt. Jogendranath Pradhan of Vill: Kourmalsali, P.O- Ichabari, P.S-Patashpur, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain & treat it as FIR.
