Subject: FIR against theft of electricity.

Dear Sir,

I do hereby lodge this written complaint empowered by the electricity act 2003 read with amendment act 2007 to the effect that one Sri Tapan Kumar Bera, S/O: Lt. Sudhakrishna Bera (as collected) of Village : Bagmari, P.O. : Pratapdighi, P.S.: Patashpur, Dist. : Purba Medinipur has committed theft of electricity under section 135 of the electricity act 2003 with amendment act 2007 as stated hereunder.

On 24.04.2017 at about 3.00 pm I, Sri Aniruddha Hazra, AE & SM, Patashpur CCC along with Sri Arunangshu Mondal, SAE (E), Patashpur CCC & Sri Tapan Kumar Das, Hg. Sr. TSH, Patashpur CCC and others went to inspect the agricultural field of Bagmari mouza as a part of routine supervisory checking and found that one Sri Tapan Kumar Bera, S/O: Lt. Sudhakrishna Bera (as collected) of the same village was engaged in unauthorized use of electricity at his agricultural premises by means of direct hooking from the nearby single phase two wire LT overhead line by connecting one black colored PVC coated aluminum conductor & another white colored PVC coated copper conductor with hooking device to run one no single phase motor with a tune of load 2 HP for agricultural purpose for his wrongful gain causing loss of energy and revenue of WBSEDCL.

As theft of electricity was detected, both of the said electrical conductor along with their hooking device were disconnected from the live electrical network of WBSEDCL and some portion approx. i.e. around 2 meter each of the said 2 no PVC coated conductor as sample along with the hooking device was seized in presence of the witness and signature of the witness obtained on the seizure list. The seized article were duly packed and labeled at the inspection site and the signature of the witness obtained on the label. Sri Tapan Kumar Bera was present during inspection but refused to sign. The inspection team left the aforesaid premises at about 3.30 pm.

The accused Sri Tapan Kumar Bera, S/O: Lt. Sudhakrishna Bera (as collected) of Village : Bagmari, P.O. : Pratapdighi, P.S.: Patashpur, Dist. : Purba Medinipur has committed theft of electricity under section 135(i)(a) of electricity act 2003 with amendment act 2007.

You are hereby requested to take cognizance of this offence and treat this complaint as FIR.
