Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Chandan Maity, S/O- Banbihari Maity of Vill: Kulrakhi, P.O- Katranka, P.S-Patashpur, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 07.03.2017 at about 01:30 PM, I, Sri Aniruddha Hazra, AE & SM, Patashpur CCC, along with Sri Manas Maity, A.E.(U), Sri Pradip Kr Chakraborty, SO all are (S&LP), Contai Division Office, Sri Bechan Prasad Barai, Hg. Sr. LM, Patashpur CCC and Sri Trilochan Bagdi, Hg. Sr. TSH Patashpur CCC had been to the Vill: Kulrakhi, P.S-Patashpur for routine inspection purpose. At first we went to the Agriculture premises of Sri Chandan Maity, S/O- Banbihari Maity of Vill: Kulrakhi, P.O- Katranka, P.S-Patashpur, Dist-Purba Medinipur and during inspection it was found that Sri Chandan Maity, S/O- Banbihari Maity of Vill: Kulrakhi, P.S-Patashpur, consuming electricity unauthorisedly by way of direct hooking for meter bypassing in respect of Consumer Id No: 200890210, Meter No: GX042056, in view of less recording of unit or energy in to the energy meter for his wrongful gain, causing loss of revenue to WBSEDCL in the tune of load 6.580 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 3 (three) nos. separated single core stranded black, yellow and blue colour PVC coated 2.5 sq mm copper conductor of length 2 (two) meter each approx along with hooking device used to run the agricultural pump-motor set unauthorisedly for bypassing the energy meter as a sample were seized under memo of seizure list in presence of consumer and witnesses. The consumer refused to sign but signature of the witness duly obtained. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 02:00 PM.

Thus Sri Chandan Maity, S/O- Banbihari Maity of Vill: Kulrakhi, P.O- Katranka, P.S-Patashpur, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
