I do hereby lodge complaint empowered by the Electricity Act, 2003 to the effect that Sri Surajit Mann, S/O- Narayan Mann, Village- Bijoyagar, P.O Paschim Chilka, PS- Panskura, Dist- Purba Medinipur has committed theft of electricity U/S 135 of the E. Act, 2003 read with Amendment Act, 2007 as stated here under

On 27.12.2016 at about 08:00 am, I Sri Uttiya Roy Chowdhury, A/E & SM, Gourangapur Customer Care Centre along with (i) Sri Palash Maji, SAE(E), Gourangapur C.C.C. (ii) Sri Rajib Gorai, O.E, Gourangapur C.C.C. went to the Agriculture(Rural) premises of Surajit Mann, S/O- Narayan Mann, Village- Bijoyagar, P.O Paschim Chilka, PS- Panskura, Dist- Purba Medinipur and found that he was consuming electricity dishonestly by way of direct hooking from the nearest L.T.O.H. mains of WBSEDCL. As theft of electricity was detected during the inspection some portion of PVC Alm. wire with hooking device was seized in presence of the witnesses and their signatures obtain on the seizer list. The seized article are duly packed, sealed & labeled at the inspection site and signatures of the witnesses obtain on the sealing label.

The inspection team left the aforesaid premises on 27.12.2016 at about 08:20 am. Thus the Surajit Mann, S/O- Narayan Mann, Village- Bijoyagar, P.O Paschim Chilka, PS- Panskura, Dist- Purba Medinipur has committed an offence U/S 135(1) (a) of E. Act, 2003 read with Amendment Act, 2007.
