Sir,

In producing herewith the arrested accused person namely Uttam Nayak (45 yrs) s/o Bimal Nayak, of Islampur, PS-Ramnagar, Dist-Purba Medinipur along with 05 (five) bottles Country Spirit each 600ml l, PSI Mukul Mallick of Ramnagar PS do hereby lodge complaint against the above noted arrested accused person to the effect that on 12.04.17 at 22.15 hrs l, along with C/472 Biswajit Das & C/1433 Rabindra Nath Maity, all of Ramnagar PS left for mobile duty vide Ramnagar PS C.C. No. 934 dt. 12.04.17 and GDE No. 544 dt. 12.04.17. During mobile duty on 12.04.17 at 23.55 hrs found that the above noted accused person is selling liquors to the different customers at Islampur under Ramnagar PS from his open shop. On seeing police he tried to run away but we managed to apprehend the above mentioned accused person who was selling liquors to different customers. On asking, he disclosed his name and address. On search the below noted liquors were found in his shop. On enquiry, it was known that he was conducting the business of selling of liquors without any license since long days. On demand he failed to produce any license for possessing / selling of the liquors and any papers regarding possession of such quantity of liquors. So, I arrested the above noted accused person on 13.04.17 at 00.15 hrs and seized below noted quantity of liquors from his possession under proper seizure list duly signed by the witnesses on 13.04.17 in between at 00.20 hrs to 00.35 hrs.

**Description of the seized items:**

1. Country Spirit each 600 ml. X 05 (five) bottles.

I also took 01 (One) bottle Country Spirit from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So I pray that a specific case may kindly be started against the arrested accused person namely Uttam Nayak (45 yrs) s/o Bimal Nayak, of Islampur, PS-Ramnagar, Dist-Purba Medinipur U/S 46A(c) of Bengal Excise Act-1909.
