In producing herewith one arrested accused person namely Prakash Maity (23 yrs.) S/O Asit Maity of Vill Kamarberiya, PS Contai, Dist Purba Medinipur along with one seized motor cycle (Hero Glamour black & blue coloured) having Engine No. JA06EJF9E16579, Chassis No. MBLJA06AMF9E17438. I, ASI Debasis Bose of Ramnagar PS do hereby submit a written complaint to the effect that on 12.01.17 at 16:15 hrs I along with C/472 Biswajit Das, C/1082 Madhusudhan Dolui both of Ramnagar PS left for PS area for performing Special mobile duty vide Ramnagar PS GDE No. 473 dated. 12.01.17 and C.C No. 112/17 dated. 12.01.17. During mobile duty around 17:25 hrs while we were checking motor cycle in front of Sapua Petrol pump then above noted person came there from Contai side with above noted motor cycle. We requested him to stop but seeing the Police party he tried to flee away and fallen on road and received minor injury in his right leg. Somehow we managed to apprehend him. On being asked he disclosed his identity as above and failed to give any satisfactory answer regarding the ownership of motor cycle as well as failed to produce any valid documents in respect of the motor cycle. He also stated that this is a stolen motor cycle and he habitually deals with such kind of business. Finding no other alternative, I arrested him maintaining all norms and seized the below noted motor cycle from his possession after preparing proper seizure list duly signed by the witnesses as well as the accused person.

Seized articles:-

- 1) One black & blue Coloured Hero Glamour Motor Cycle bearing Engine No. JA06EJF9E16579, Chassis No. MBLJA06AMF9E17438.

Therefore I pray before your kind honour that a specific case may kindly be initiated against the above noted accused person under proper section of law.
