Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Tapas Das (User), S/O- Lt. Basanta Das of Vill: Kulbudhi, P.O- Hirapur, P.S-Ramnagar, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 05.05.2017 at about 03:00 PM, I, Sri Angshuman Nag, AE & SM Digha CCC, along with Sri Bhutnath Mudi, SAE (E), Digha CCC, Sri Jadu Nath Sahoo, ACM Digha CCC and Sri Manas Maity, A.E.(U), Sri Pradip Kr Chakraborty, SO both are of (S&LP) Wing, Contai Division Office had been to the Vill: Kulbudhi, P.S-Ramnagar for routine inspection purpose. At first we went to the Domestic premises of Sri Tapas Das and Sri Manas Kr Das, S/O- Lt. Basanta Das of Vill: Kulbudhi, P.O- Hirapur, P.S-Ramnagar, Dist-Purba Medinipur and during inspection it was found that Sri Tapas Das, S/O- Lt. Basanta Das of Vill: Kulbudhi, P.S-Ramnagar, Dist-Purba Medinipur consuming electricity unauthorisedly by way of bypassing the energy meter by tempering the incoming service cable in respect of Consumer Id No: 223010661, Meter No: ML513696, which is in the name of Sri Manas Kr Das, S/O- Lt. Basanta Das, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 1.17 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of two core round shape, black colour PVC coated 6.0 sq mm tampered service cable made of aluminium of length 1 (one) meter (approx) alongwith bypass arrangement made by another single core black colour PVC coated 1.5 sq mm copper wire of length 1 (one) meter (approx) as a sample were seized under memo of seizure list in presence of Smt. Manasi Das, W/O- Sri Tapas Das as a representative of the user and witnesses and duly signed by them. Smt. Manasi Das, W/O- Sri Tapas Das acknowledged the same by putting her signature in the Seizure List, Inspection Report Thereafter the seized articles were packed and labeled at the inspection site in presence of representative of the consumer and witness and signature of witnesses and Smt. Manasi Das, W/O- Sri Tapas Das (User) obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 03:30 PM.

Thus Sri Tapas Das (User), S/O- Lt. Basanta Das of Vill: Kulbudhi, P.O- Hirapur, P.S-Ramnagar, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
