Sub. : F.I.R. against unauthorized seller of liquors.

Sir,

In producing herewith the arrested accused person namely Sk Sajed (26 yrs) s/o Sk. Harmuch of Kasba Asunda, PO Lalnagar PS-Belda, Dist-Paschim Medinipur along with Country Spirit each 600 ml. X 10 (ten) bottles only. I PSI Mukul Mallick of Ramnagar PS do hereby lodge complaint against the above noted arrested accused person to the effect that on 08.05.17 at 05.35 hrs, I received a source information that some persons are selling liquor at Santeswarpur under PS Ramnagar, then myself along with C/467 Rabindar Nath Maity, C/99 Sanjay Santra, both of Ramnagar PS left for mobile duty at PS area in course of night mobile duty vide Ramnagar PS GDE No. 297, dt. 07.05.17. During mobile duty on 08.05.17 at about 06.05 hrs we reached Santeswarpur and found that two persons were selling liquors to the different customers at Santeswarpur at the house of Sk Ajid under Ramnagar PS. On seeing Police they tried to run away but we managed to apprehend one of them namely Sk Sajed who was selling liquors to different customers. Another namely Sk Ajid of Santeswarpur managed to runaway. On ask, he disclosed his name in above noted. On search we found noted liquors in his house. On enquiry, it could be learnt that he was conducting the business of selling of without any licenses few some days. On demand he failed to produce any license for possessing / selling of the liquors and any paper regarding possession of such quantity of liquors. I have seized below noted quantity of alcoholic liquors from his possession under proper seizure list and label duly signed by the witnesses on 08.05.17 in between at 06.25 hrs and 06.55 hrs. Then I arrested accused Sk Sajed (26 yrs) s/o Sk. Harmuch of Kasba Asunda, PO Lalnagar PS-Belda, Dist-Paschim Medinipur under proper Memo of arrest and informed regarding in ground of his arrest.

Description of the seized items:

- i. Country Spirit each 600 ml. X 10 (ten) bottles only..

I also took 01 (One) bottle Country Spirit from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So, I pray that a specific case may kindly be started against the accused person 1. Sk Sajed (26 yrs) s/o Sk. Harmuch of Kasba Asunda, PO Lalnagar PS-Belda, Dist-Paschim Medinipur, 2. Sk Ajid of Santeswarpur, PS-Ramnagar, U/S 46A(c) of Bengal Excise Act-1909.
