Sir,

In producing herewith the arrested accused person namely Jhareswar Behera (38 yrs) S/O Lt. Bankim Behera of Nimajpur, PS. Bhograi, Dist. Balasore, Odisha along with 10 (Ten) bottles Country Spirit each 600ml and 20 Ltrs. ID Liquor with one plastic Jarikan I, ASI Tapas Patra of Ramnagar PS do hereby lodge complaint against the above noted arrested accused person to the effect that on 16.01.17 at 15:35 hrs I, along with C/718 Shymal Pathak and C/472 Biswajit Das both of Ramnagar PS left for mobile duty vide GDE No. 651 dt. 16.01.17. During mobile duty on 16.01.17 at 19:05 hrs found that the above noted accused person is selling liquors to the different customers at Sagareswar under Ramnagar PS from his temporary shop. On seeing Police he tried to run away but we managed to apprehend the above mentioned accused person who was selling liquors to different customers. On asking, he disclosed his name as above. On search the below noted liquors were found in his shop. On enquiry, it was known that he was conducting the business of selling of liquors without any license since last few days. On demand he failed to produce any license for possessing/ selling of the liquors and any paper regarding possession of such quantity of liquors. So, I arrested the above noted accused person on 16.01.17 at 19:15 hrs and seized below noted quantity of liquors from his possession under proper seizure list duly signed by the witnesses on 16.01.17 in between 19:25 hrs to 19:35 hrs.

Description of the seized items:

- 1) Country Spirit each 600 ml. X 10 (Ten) bottles.
- 2) 20 Ltrs. ID Liquor with One plastic Jarikan.

I also took 01 (One) bottle Country Spirit & 01 Ltrs. ID Liquor from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So I pray that a specific case may kindly be started against the arrested accused person namely Jhareswar Behera (38 yrs) S/O Lt. Bankim Behera of Nimajpur, PS. Bhograi, Dist. Balasore, Odisha U/S 46A(c) of Bengal Excise Act-1909.
