Sir,

In producing herewith 12 (twelve) bottles of Sun Fighter Spirit, Country Spirit each 600ml in 01 (one) Nylon bag I, SI Mohan Bhattacharjee of Ramnagar PS do hereby lodge complaint against accused person Shibaprasad Maity(40) s/o Lt. Surendra Nath Maity of Hamirpur, PS-Ramnagar, Dist-Purba Medinipur to the effect that on 22.05.17 at 19.45 hrs, on telephonic information from my source I, along with C/1433 Rabindra Nath Maity, C/568 Kamal Ali Khan along with Civic Volunteers, all of Ramnagar PS left for Hamirpur under Ramnagar PS vide Ramnagar PS GDE No. 1341 dt. 22.05.17. During mobile duty on 22.05.17 at 20:15 hrs we found that accused person Shibaprasad Maity s/o Lt. Surendra Nath Maity of Hamirpur, PS-Ramnagar, Dist-Purba Medinipur is selling liquors to the different customers at Hamirpur under Ramnagar PS from his house/shop. On seeing Police he fled away near a Kaju Garden. On enquiry, it was known that he was conducting the business of selling of liquors without any license since last few months. So, I seized below noted quantity of liquors from his house/shop under proper seizure list and label duly signed by the witnesses on 22.05.17 in between 20.35 hrs to 20:45 hrs.

**Description of the seized items:**

- 1) 12 (twelve) bottles of Sun Fighter Spirit, Country Spirit each 600ml, bottle price RS. 65.00 per bottle. Total amount RS. (65 x 12) = Rs. 780.00.
- 2) 01 (one) Nylon bag.

I also took 01 (One) bottle Sun Fighter Spirit, Country Spirit 600 ml from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So I pray that a specific case may kindly be started against accused person namely Shibaprasad Maity (40) s/o Lt. Surendra Nath Maity of Hamirpur, PS-Ramnagar, Dist-Purba Medinipur U/S 46A(c) of Bengal Excise Act-1909.
