Sir,

In producing herewith 25 (twenty five) bottles of Sun Fighter Spirit, Country Spirit each 600ml in 01 (one) Nylon bag I, ASI Bimalendu Das of Ramnagar PS do hereby lodge complaint against accused person Smt. Laxmipriya Patra (65) w/o Brindaban Patra of Bararankua, PS-Ramnagar, Dist-Purba Medinipur to the effect that on 29.05.17 at 08.05 hrs, during my mobile duty (vide Ramnagar PS GDE No. 1422 dt. 29.05.17), I received a telephonic information from my source. I along with C/99 Sanjoy Santra, C/568 Kamal Ali Khan & LC/1218 Purnima Giri, all of Ramnagar PS left for Bararankua. During mobile duty on 29.05.17 at 08:35 hrs we found that accused person Smt. Laxmipriya Patra w/o Brindaban Patra of Bararankua, PS-Ramnagar, Dist-Purba Medinipur is selling liquors to the different customers at Bararankua under Ramnagar PS from her house/shop. On seeing us she tried to run away but we managed to apprehend the above mentioned accused person who was selling liquors to different customers. On asking she disclosed her name as above. On search, the below noted liquors were found in her house. On enquiry it was known that she was conducting the business of selling of liquors without any license since last few days. On demand she failed to produce any license for possessing / selling of the liquors and any paper regarding possession of such quantity of liquors. So, I seized the following liquors from her possession under proper seizure list duly signed by the witnesses and arrested the above noted accused person.

**Description of the seized items:**

- 1) 25 (twenty five) bottles of Sun Fighter Spirit, Country Spirit each 600ml, bottle price RS. 65.00 per bottle. Total amount RS. (65 x 25) = Rs. 1625.00.
- 2) 01 (one) Nylon bag.

I also took 02 (two) bottle Sun Fighter Spirit, Country Spirit 600 ml from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So I pray that a specific case may kindly be started against the arrested accused person namely Smt. Laxmipriya Patra (65) w/o Brindaban Patra of Bararankua, PS-Ramnagar, Dist-Purba Medinipur U/S 46A(c) of Bengal Excise Act-1909.
