Sir,

In producing herewith the arrested accused person namely Sujit Karan (45 yrs) S/O Debakar Karan of Dharas, PS. Ramnagar, Dist. Purba Medinipur, along with 67 (Sixty-seven) bottles Country Spirit each 600ml in 05 (five) Nylon bag I, PSI Mukul Mallick of Ramnagar PS do hereby lodge complaint against the above noted arrested accused person to the effect that on 30.05.17 at 08:05 hrs I, along with C/48 Naba Kumar Manna and C/1033 Gurucharan Dey both of Ramnagar PS left for mobile duty vide Ramnagar PS CC No. 1474/17 dt. 30.05.17 GDE No. 1675 dt. 30.05.17. During mobile duty on 30.05.17 at 08:45 hrs we found that the above noted accused person is selling liquors to the different customers at Dharas under Ramnagar PS from his temporary shop. On seeing Police he tried to run away but we managed to apprehend the above mentioned accused person who was selling liquors to different customers. On asking, he disclosed his name as above. On search the below noted liquors were found in his shop. On enquiry, it was known that he was conducting the business of selling of liquors without any license since last few days. On demand he failed to produce any license for possessing/ selling of the liquors and any paper regarding possession of such quantity of liquors. So, I seized below noted quantity of liquors from his possession under proper seizure list and label duly signed by the witnesses on 30.05.17 in between 08:55 hrs to 09:15 hrs and also arrested the above noted accused person on 30.05.17 at 09:15 hrs.

**Description of the seized items:**

- 1) 67 (Sixty seven) bottles of Sun Fighter Spirit, Country Spirit each 600ml, bottle price RS. 65.00 Per bottle. Total amount RS. (65 x 57) = Rs. 4355.00.
- 2) 05 (Five) Nylon bag.

I also took 01 (One) bottle Country Spirit from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So I pray that a specific case may kindly be started against the arrested accused person namely Sujit Karan (45 yrs) S/O Debakar Karan of Dharas, PS. Ramnagar, Dist. Purba Medinipur U/S 46A(c) of Bengal Excise Act-1909.
