Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Ananta Jana, S/O - Jitendranath Jana, a permanent resident of Vill-Dakshin Thiar, P.O -Balisai, P.S -Ramnagar, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 05.06.2017 at about 12:30 PM I, Sri Jayanta Panda, AE & SM, Pichhaboni CCC along with Sri Manas Maity, AE (U), Sri Pradip Kr Chakraborty, SO both are of S&LP, Contai Division Office, Sri Ramkrishna Jana, LM Pichhaboni CCC, Sri Satya Singh, TSH, Pichhaboni CCC and others had been to the village- Dakshin Thiar for routine inspection purpose. During inspection it was found that Sri Ananta Jana was consuming electricity dishonestly in his Domestic premises unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 0.600 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 1 (One) number single core pink coloured PVC coated 7/20 SWG copper conductor of length 2.5 (Two & half) meter (approx) each along with hooking device used to run the electrical appliances for Domestic purpose has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Rahul Jana, S/O-Ananta Jana acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 01:00 PM.

Thus the accused Sri Ananta Jana, S/O - Jitendranath Jana, Vill - Dakshin Thiar, P.O -Balisai, P.S -Ramnagar, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
