Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Bibhuti Bhusan Sahu, S/O- Lt. Narendranath Sahu of Vill: Thiyar, P.O- Balisai, P.S-Ramnagar, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 05.06.2017 at about 01:30 PM, I, Sri Manas Maity, A.E.(U), (S&LP), Contai Division Office, along with Sri Jayanta Panda, AE & SM, Pichhaboni CCC, Sri Ramkrishna Jana, LM Pichhaboni CCC and others had been to the Vill: Thiyar, P.S-Ramnagar for routine inspection purpose. At first we went to the Domestic premises Sri Bibhuti Bhusan Sahu, S/O- Lt. Narendranath Sahu of Vill: Thiyar, P.O- Balisai, P.S-Ramnagar, Dist-Purba Medinipur and during inspection it was found that Sri Bibhuti Bhusan Sahu, S/O- Lt. Narendranath Sahu of Vill: Thiyar, P.S-Ramnagar, Dist-Purba Medinipur consuming electricity unauthorisedly by way of direct hooking through 1 (one) no stranded single core black colour PVC coated 2.5 sq mm copper conductor by fixing a changer arrangement for meter bypassing in respect of Consumer Id No: 201066055, Meter No: L4891587, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 1.170 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 1 (one) no stranded single core black colour PVC coated 2.5 sq mm copper conductor of length 5 (five) meter approx along with hooking device and one 25/32 Amp: JJ Plus make Changer fitted with wooden board and one yellow card vide SL No - 1082067 in the name of Sri Bibhuti Bhusan Sahu as a samlpe were seized under memo of seizure list in presence of representative of the consumer and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of Smt Kabita Sahu W/O- Sri Bibhuti Bhusan Sahu and witness and signature of witnesses and representative of the consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 02:00 PM.

Thus Sri Bibhuti Bhusan Sahu, S/O- Lt. Narendranath Sahu of Vill: Thiyar, P.O- Balisai, P.S-Ramnagar, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
