In producing herewith 29 (Twenty-nine) bottles Country Spirit each 600ml in 02 (Two) Nylon bag I, ASI Sourav Praharaj of Ramnagar PS do hereby lodge complaint against accused person namely Bajendra Shee s/o Late Mritunjoy Shee of Sadi, PO. Sadihat, PS. Ramnagar, Dist. Purba Medinipur to the effect that on 09.06.17 at 14:05 hrs I, along with C/990 Chinmoy Nandi and C/1559 Uttam Kr. Ghosh all of Ramnagar PS left for evening mobile duty vide Ramnagar PS GDE No. 413 dt. 09.06.17, CC No. 1402 dt. 09.06.17. During mobile duty on 09.06.17 at 20:05 hrs we found that accused person Bajendra Shee s/o Late Mritunjoy Shee of Sadi, PO. Sadihat, PS. Ramnagar, Dist. Purba Medinipur was selling liquors to the different customers at Balakbarh under Ramnagar PS from his temporary shop. On seeing Police he fled away. On enquiry, it was known that he was conducting the business of selling of liquors without any license since last few months. So, I seized below noted quantity of liquors from his temporary shop under proper seizure list and label duly signed by the witnesses on 09.06.17 in between 20.25 hrs to 20:35 hrs.

Description of the seized items:

- 1) 29 (Twenty-nine) bottles of Sun Fighter Spirit, Country Spirit each 600ml, bottle price RS. 65.00 Per bottle. Total amount RS. (65 x 29) = Rs. 1885.00.
- 2) 02 (Two) Nylon bag.

I also took 01 (One) bottle Country Spirit from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So I pray that a specific case may kindly be started against the accused person namely Bajendra Shee s/o Late Mritunjoy Shee of Sadi, PO. Sadihat, PS. Ramnagar, Dist. Purba Medinipur U/S 46A(c) of Bengal Excise Act-1909.
