Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Nirmal Kr Maity, S/O- Lt. Paresh Chandra Maity of Vill: Kaluasanda, P.O- & P.S-Ramnagar, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 21.06.2017 at about 01:00 PM, I, Sri Angshuman Nag, AE & SM, Digha CCC along with Sri Manas Maity, AE (U), Sri Pradip Kr Chakraborty, SO all are of S&LP unit of Contai Division Office Sri Bhutnath Mudi, SAE (E), Digha CCC, Sri Jadu Nath Sahoo, ACM, Digha CCC and others had been to the Vill: Kaluasanda, P.S-Ramnagar for routine inspection purpose. At first we went to the Domestic premises Sri Nirmal Kr Maity, S/O- Lt. Paresh Chandra Maity of Vill: Kaluasanda, P.O- & P.S-Ramnagar, Dist-Purba Medinipur and during inspection it was found that Sri Nirmal Kr Maity, S/O- Lt. Paresh Chandra Maity of Vill: Kaluasanda consuming electricity unauthorisedly by the way of bypassing the energy meter by tampering the incoming service cable before entry into the energy meter in respect of Consumer Id No: 223089219, Meter No: T067172, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 1.17 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from the pole and some portion of 2 (two) core round shape black colour PVC coated 6 sq mm aluminium make tampered service cable of length 2 (two) meter (approx) along with bypass arrangement made by another 2 (two) core flat type 1.5 sq mm copper (single core) conductor of length 1 (one) meter approx as a sample were seized under memo of seizure list in presence of consumer and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 01:30 PM.

Thus Sri Nirmal Kr Maity, S/O- Lt. Paresh Chandra Maity of Vill: Kaluasanda, P.O- & P.S-Ramnagar, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
