Sir,

In producing herewith one arrested male accused person namely Sk Mainuddin (35) S/O Sk Nuruddin of Vill-Raipur, PS-Contai, Dist-Purba Medinipur, in custody, with memo of arrest, and seized one Damper bearing Registration No. OR 01L/9879 loaded with sand approx. 550 CFT (Five hundred Fifty cft.) and one Tractor bearing Registration No. WB 31/6211 loaded with sand approx. 150 CFT (One hundred Fifty cft.), I ASI Bimalendu Das beg to submit that on 01.07.17 evening I was assigned with evening mobile duty along with C/99 Sanjoy Santra and C/840 Tapan Shit, both of Ramnagar PS vide CC No 1631/17 and GDE No 24 dt 01.07.17. On 01.07.17 at about 15.15 hrs duty during patrolling at Kathpul Bazar area under Ramnagar PS, I found one Damper and Tractor sand loaded were moving towards Contai side having Registration No. OR 01L/9879 & WB 31/6211. I made the vehicles stop and demanded necessary documents of sand which were found loaded on the above Damper and Tractor. The driver of said Damper was managed to flee away. The driver of Tractor who disclosed his identity as Sk Mainuddin (35) S/O Sk Nuruddin of Vill-Raipur, PS-Contai, Dist-Purba Medinipur failed to produce any document in respect of the sand, on the Tractor and also the documents of the Tractor. On interrogation he stated that he procured the sand from Kathpul Bazar area and was going towards Contai. The driver also disclosed that they are habitual in dealing of such illegally procured sand loaded it on the Tractor by illegal means and they are habituated in this type of illegal dispatching. The sand inside the Tractor was found 150 C.F.T (approx) as stated by the driver. He also stated that the owner of the above noted Damper was Dilu Hossion of Khangraboni, PS-Contai, Dist-Purba Medinipur and he also involved in such type of illegal business. However, in this locality no certificate regarding the measurement of sand could be collected as no such office was available at that time. Then, I seized the Damper bearing Registration No. OR 01L/9879 loaded with sand approx. 550 CFT (Five hundred Fifty cft.) and one Tractor bearing Registration No. WB 31/6211, loaded with 150 CFT. (approx) sand. I also arrested the driver of Tractor Sk Mainuddin (35) S/O Sk Nuruddin of Vill-Raipur, PS-Contai, Dist-Purba Medinipur as he had committed offence punishable U/S 379/411/413/414 IPC read with 21 The Mines and Minerals (Development and Regulation) Act, 1957. During arrest he was informed about the ground of arrest.

Under such circumstances I do hereby lodge complaint against (i) Sk Mainuddin (35) S/O Sk Nuruddin of Vill-Raipur, PS-Contai, Dist-Purba Medinipur, (ii) Dilu Hossion of Khangraboni, PS-Contai, Dist-Purba Medinipur, (iii) the driver of Damper bearing Registration No. OR 01L/9879 and others who are involved such type of illegal trading of sand without permission causing loss of Govt. revenue, for their involvement in crime punishable U/S 379/411/413/414 IPC read with 21 The Mines and Minerals (Development and Regulation) Act, 1957 and pray to start a case for investigation.
