Sir,

In producing herewith the arrested accused person namely Nimal Barik (50) s/o Lt. Dinabandhu Barik of Talgachari, PS-Ramnagar, Dist-Purba Medinipur, along with Haywards 5000 beer each 650ml. X 16(sixteen) bottles and Officer's Choice Prestige Whisky each 375 ml. X 4(four) bottles I, SI Mohan Bhattacharjee of Ramnagar PS do hereby lodge complaint against the above noted arrested accused person to the effect that on 01.07.17 at 16.25 hrs I, along with C/472 Biswajit Das & C/967 Kalipada Das, both of Ramnagar PS left for mobile duty vide Ramnagar PS GDE No. 925 dt. 01.07.17. During mobile duty on 01.07.17 at about 20.30 hrs we found that the above noted accused person is selling liquors to the different customers at Talgachari under Ramnagar PS from his house. On seeing Police he tried to run away but we managed to apprehend the above mentioned accused person who was selling liquors to different customers. On asking, he disclosed his name as above. On search the below noted liquors were found in his possession. On enquiry, it was known that he was conducting the business of selling of liquors without any license since last few days. On demand he failed to produce any license for possessing/ selling of the liquors and any paper regarding possession of such quantity of liquors. So, I seized below noted quantity of liquors from his possession under proper seizure list and label duly signed by the witnesses on 01.07.17 in between 20.25 hrs to 20.35 hrs and also arrested the above noted accused person on 01.07.17 at 20:35 hrs

Description of the seized items:

1. Haywards 5000 beer each 650ml. X 16(sixteen) bottles.
2. Officer's Choice Prestige Whisky each 375 ml. X 4(four) bottles.

I also took 01 (One) bottle Haywards 5000 beer and 01 (One) bottle Officer's Choice Prestige Whisky from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So I pray that a specific case may kindly be started against the arrested accused person namely Nimal Barik (50) s/o Lt. Dinabandhu Barik of Talgachari, PS-Ramnagar, Dist-Purba Medinipur U/S 46A(c) of Bengal Excise Act-1909.
