Sir,

In producing herewith the arrested accused person namely Pradip Giri (45 yrs) S/O Lt. Chintamoni Giri of Sabitrapur, PS. Ramnagar, Dist. Purba Medinipur, along with 09 (Nine) bottles Country Spirit each 600ml, 04 (Four) bottles Officer Choice, Whisky each 180 ml and 20 (Twenty) Ltrs. ID Liquor in a plastic Jarikan. I, SI Mohan Bhattacharjee of Ramnagar PS do hereby lodge complaint against the above noted arrested accused person to the effect that on 06.07.17 at 19.45 hrs I, along with C/840 Tapan Shit and C/149 Somnath Mandi both of Ramnagar PS left for special mobile duty vide Ramnagar PS GDE No. 270 dt. 06.07.17. During mobile duty on 06.07.17 at 20.25 hrs we found that the above noted accused person is selling liquors to the different customers at Mahakal under Ramnagar PS from his temporary shop. On seeing Police he tried to run away but we managed to apprehend the above mentioned accused person who was selling liquors to different customers. On asking, he disclosed his name as above. On search the below noted liquors were found in his shop. On enquiry, it was known that he was conducting the business of selling of liquors without any license since last few days. On demand he failed to produce any license for possessing/ selling of the liquors and any paper regarding possession of such quantity of liquors. So, I seized below noted quantity of liquors from his possession under proper seizure list and label duly signed by the witnesses on 06.07.17 in between 20.35 hrs to 20.55 hrs and also arrested the above noted accused person on 06.07.17 at 20:55 hrs. At the time of arrest it was found that there was a cut injury on his right palm. There I arrange for his treatment at Bararankua BPHC.

Description of the seized items:

- 1) 09 (Nine) bottles of Sun Fighter Spirit, Country Spirit each 600ml, bottle price RS. 65.00 Per bottle. Total amount RS. (65 x 09) = Rs. 585.00.
- 2) 04 (Four) bottles Officer Choice Whisky each 180ml, bottle price RS. 100.00 Per bottle. Total amount RS. (100 x 04) = Rs. 400.00.
- 3) 20 (Twenty) Ltrs. ID Liquor with One plastic Jarikan.

I also took 01 (One) bottle Country Spirit, 01(One) bottle Officer Choice Whisky and 01 (One) ltrs ID Liquor from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So I pray that a specific case may kindly be started against the arrested accused person namely Pradip Giri (45 yrs) S/O Lt. Chintamoni Giri of Sabitrapur, PS. Ramnagar, Dist. Purba Medinipur U/S 46A(c) of Bengal Excise Act-1909.
