Sir,

I do hereby lodge complain empowered by the Electricity Act – 2003 to the effect that Sri Sukdev Jana, S/o-Ajit Jana, Vill.- Chahaka, P.O.- Deuli, P.S. - Ramnagar committed theft of electricity U/S - 135(i) (b) of electricity Act 2003 and amendment Act 2007 as stated here under.

On 11/07/2017 at about 12.55 p.m. I, Sri Jayanta Panda, AE & SM, Pichhaboni C.C.C along with Sri Abhijit Ghara, LM; Sri Ramkrishna Jana, LM and others all attached with Pichhaboni C.C.C inspected the premises of Sri Sukdev Jana residing at Chahaka after maintaining all formalities. During inspection it was found that Sri Sukdev Jana is using electricity by way of bypassing the energy meter by tempering the incoming service cable before entry into the energy meter in respect of Consumer Id No: 200094585, Meter No: B1389718, in view of less recording of unit or energy in to the energy meter, causing loss of revenue of WBSEDCL.

Therefore, as theft of electricity was detected in the manner of U/S- 135(i) (b) of electricity act 2003 and amendment Act 2007. The purpose of using electricity was domestic with detected load of 0.65 KVA. The unauthorized line was disconnected and removed at site.

Some portion of dual core PVC cable black in colour along with tapping arrangement were seized in the presence of witness and signature are also obtained in the seizure list then packed sealed and labeled at the site of occurrence.

The inspection team then left aforesaid premises on completion of inspection at about 01.10 p.m. on 11/07/2017.

Therefore you are requested to take cognizance of this complain and treat it as FIR.
