Sir,

I do hereby lodge complain empowered by the Electricity Act - 2003 to the effect that Sri Ashoke Dash, S/o- Late Sailesh Dash, Vill. - Paschim Karanji, P.O. - Karanji, P.S. - Ramnagar has committed theft of electricity U/S - 135(i) (a) of electricity Act 2003 and amendment Act 2007 as stated here under.

On 19/01/2017 at about 11.50 a.m. I, Sri Jayanta Panda, AE & SM, along with Sri Ramkrishna Jana, LM, Rajendra Bhuniya, TSH and others all attached with Pichhaboni C.C.C, inspected the agriculture premises of Sri Ashoke Dash residing at Paschini Karanji after maintaining all formalities. During inspection it was found that Sri Ashoke Dash is using electricity by means of direct hooking from nearby LTOH line, causing loss of revenue of WBSEDCL.

Therefore as theft of electricity was detected in the manner of U/S- 135(i) (a) of electricity act 2003 and amendment Act 2007. The purpose of using electricity was Agriculture with detected load of 4.38 KVA. The unauthorized line was disconnected and removed at site.

Some portion of three separate aluminum core hooking wire green in colour along with hooking device of length each 4.5 feet approx are seized in the presence of witness and signature are also obtained in the seizure list then packed sealed and labeled at the site of occurrence.

The inspection team then left aforesaid premises on completion of inspection at about 12.10 p.m. on 19/01/2017.

Therefore you are requested to take cognizance of this complain and treat it as FIR.
