Sir,

I do hereby lodge complain empowered by the Electricity Act - 2003 to the effect that Sri Mukteswar Jana, S/o- Late Bankim Ch. Jana, Vill. - Dakshin Karanji, P.O. - Karanji, P.S. - Ramnagar has committed theft of electricity U/S - 135(i) (a) of electricity Act 2003 and amendment Act 2007 as stated here under.

On 19/01/2017 at about 12.20 p.m. I, Sri Jayanta Panda, AE & SM, along with Sri Rankrishna Jana, LM, Rajendra Bhuniya, TSH and others all attached with Pichhaboni C.C.C. inspected the premises of Sri Mukteswar Jana residing at Dakshin Karanji after maintaining all formalities. During inspection it was found that Sri Mukteswar Jana is using electricity by means of direct hooking from nearby LT/HT line, causing loss of revenue of WBS&EDCL.

The above as theft of electricity was detected in the manner of U/S- 135(i) (a) of electricity act 2003 and amendment Act 2007. The purpose of using electricity was domestic with detected load of 0.353 KVA. The unauthorized line was disconnected and removed at site.

Some portion of two separate copper core hooking wire blue and green in colour along with hooking device of length 6 feet approx are seized in the presence of witness and signature are also obtained in the seizure list then packed sealed and labeled at the site of occurrence.

The inspection team then left aforesaid premises on completion of inspection at about 12.40 p.m. on 19/01/2017.

Therefore you are requested to take cognizance of this complain and treat it as FIR.
