Sub. : F.I.R. against unauthorized seller of liquors.

Sir,

In producing herewith the arrested accused person namely Susanta Hazra(42) s/o Lt. Bijoy Krishna Hazra of Sadi, PS-Ramnagar, Dist-Purba Medinipur along with 05 (five) bottles Country Spirit each of 600ml, I ASI Debasis Bose of Ramnagar PS do hereby lodge written complaint against the above noted arrested accused person to the effect that on 03.01.17, I along with C/568 Kamal Ali Khan of Ramnagar PS, C/791 Nasim Aziz of SAP 8th Bn. Now attached with Ramnagar PS left for mobile duty at Ramnagar PS area vide Ramnagar PS GDE No. 84, dt. 03.01.17 & C.C. No. 21/17 dt. 03.01.17. During mobile duty on 03.01.17 at about 20:15 hrs found that the above noted accused person was selling liquors to the different customers from his shop at Sadi hat under Ramnagar PS. On seeing Police he tried to run away but we managed to apprehend the above mentioned accused person who was selling liquors to different customers. On ask, he disclosed his name as above. On search the below noted liquors were found in his shop. On enquiry, it was known that he was conducting the business of selling of liquors without any license since last few days. On demand he failed to produce any license for possessing / selling of alcoholic liquors and any paper regarding possession of such quantity of alcoholic liquors. So, I arrested the above noted accused person on 03.01.16 at 20.25 hrs and below noted quantity of alcoholic liquors was seized from his possession under proper seizure list duly signed by the witnesses on 03.01.17 in between at 20.35 hrs to 20.45 hrs.

Description of the seized items:

- i. 05 (five) bottles Country Spirit each of 600ml.

I also took 01 (One) bottle Country Spirit from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So, I pray that a specific case may kindly be started against the arrested accused person namely Susanta Hazra(42) s/o Lt. Bijoy Krishna Hazra of Sadi, PS-Ramnagar, Dist-Purba Medinipur, U/S 46A(c) of Bengal Excise Act-1909.
