Sir,

In producing herewith the arrested accused person namely Shib Prasad Maity (48 yrs) S/O Lt. Surendra Nath Maity of Hamirpur, PS. Ramnagar, Dist. Purba Medinipur along with 12 (Twelve) bottles Country Spirit each 600ml I, SI Partha Pratim Maiti of Ramnagar PS do hereby lodge complaint against the above noted arrested accused person to the effect that on 26.12.16 at 15:05 hrs I, along with C/575 Janmenjoy Jana of Ramnagar PS and C/467 Biswanath Naskar of SAP 8th Bn. attached with Ramnagar PS left for mobile duty vide Ramnagar PS C.C. No. 6058/16 dt. 26.12.16 and GDE No. 1102 dt. 26.12.16. During mobile duty on 26.12.16 at 20:35 hrs found that the above noted accused person is selling liquors to the different customers at Hamirpur under Ramnagar PS from his house cum shop. On seeing police he tried to run away but we managed to apprehend the above mentioned accused person who was selling liquors to different customers. On asking, he disclosed his name as above. On search the below noted liquors were found in his shop. On enquiry, it was known that he was conducting the business of selling of liquors without any license since last few days. On demand he failed to produce any license for possessing/ selling of the liquors and any paper regarding possession of such quantity of liquors. So, I arrested the above noted accused person on 26.12.16 at 20:45 hrs and seized below noted quantity of liquors from his possession under proper seizure list duly signed by the witnesses on 26.12.16 in between 20:55 hrs to 21:05 hrs.

Description of the seized items:

1) Country Spirit each 600 ml. X 12 (Twelve) bottles.

I also took one bottle Country Spirit 600 ml from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So I pray that a specific case may kindly be started against the arrested accused person namely Shib Prasad Maity (48 yrs) S/O Lt. Surendra Nath Maity of Hamirpur, PS. Ramnagar, Dist. Purba Medinipur U/S 46A(c) of Bengal Excise Act-1909.
