Sir,

I do hereby lodge complain empowered by the Electricity Act - 2003 to the effect that Sri Bapi Samanta, S/o- Late Sarat Samanta, Vill. - Baksipur, P.O. - Maitana, P.S. - Ramnagar has committed theft of electricity U/S - 135(i)(a) of electricity Act 2003 and amendment Act 2007 as stated here under.

On 26/12/2016 at about 11.40 a.m. I, Sri Jayanta Panda, AE & SM, along with Sri Krishnapada Manna, LM, Sri Rajkishor Das, TSH and others all attached with Pichhaboni C.C.C. inspected the premises after maintaining all formalities of Sri Bapi Samanta residing at Baksipur. During inspection it was found that Sri Bapi Samanta is using electricity by means of direct hooking from nearby LTOH line, causing loss of revenue of WBSEDCL.

Therefore, as theft of electricity was detected in the manner of U/S- 135(i) (a) of electricity act 2003 and amendment Act 2007. The purpose of using electricity was Agriculture with detected load of 0.746 KW. The unauthorized line was disconnected and removed at site.

Some portion of dual core hooking PVC cable black in colour along with hooking device of length 4 meter approx are seized in the presence of witness and signature are also obtained in the seizure list then packed sealed and labeled at the site of occurrence.

The inspection team then left aforesaid premises on completion of inspection at about 12.00 p.m. on 26/12/2016.

Therefore you are requested to take cognizance of this complain and treat it as FIR.
