Sub. : F.I.R. against unauthorized seller of liquors.

Sir,

In producing herewith the arrested accused person namely Ajit Kumar Jana (45) s/o Lt. Ananta Jana of Alalpur, PS-Contai, Dist. Purba Medinipur along with 05 (five) bottles Country Spirit each of 600ml, I SI Partha Pratim Maiti of Ramnagar PS do hereby lodge written complaint against the above noted arrested accused person to the effect that on 30.12.16, I along with C/149 Somnath Mandi, C/840 Tapan Shit, both of Ramnagar PS left for mobile duty at Ramnagar PS area vide Ramnagar PS GDE No. 1353, dt. 30.12.16 & C.C. No. 6100 dt. 30.12.16. During mobile duty on 30.12.16 at about 07.15 hrs found that the above noted accused person was selling liquors to the different customers from his shop at Kathpul Bazar under Ramnagar PS. On seeing Police he tried to run away but we managed to apprehend the above mentioned accused person who was selling liquors to different customers. On ask, he disclosed his name as above. On search the below noted liquors were found in his shop. On enquiry, it was known that he was conducting the business of selling of liquors without any license since last few days. On demand he failed to produce any license for possessing / selling of alcoholic liquors and any paper regarding possession of such quantity of alcoholic liquors. So, I arrested the above noted accused person on 30.12.16 at 07.25 hrs and below noted quantity of alcoholic liquors was seized from his possession under proper seizure list duly signed by the witnesses on 30.12.16 in between at 07.35 hrs to 07.45 hrs.

Description of the seized items:

- i. 05 (five) bottles Country Spirit each of 600ml.

I also took 01 (One) bottle Country Spirit from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So, I pray that a specific case may kindly be started against the arrested accused person namely Ajit Kumar Jana (45) s/o Lt. Ananta Jana of Alalpur, PS-Contai, Dist. Purba Medinipur, U/S 46A(c) of Bengal Excise Act-1909.
