Sir,

I do hereby lodge complain empowered by the Electricity Act - 2003 to the effect that Sri Sudip Patra (User), S/o- Late Sudhir Patra, Vill.- Uttar Kadua, P.O. - Sishusadan, P.S. - Ramnagar has committed theft of electricity U/S - 135(i) (a) of electricity Act 2003 and amendment Act 2007 as stated here under.

On 16/02/2017 at about 11.30 a.m. I, Sri Jayanta Panda, AE & SM, Pichhaboni C.C.C along with Sri Krishnapada Manna, LM, Sri Manomay Chandra, JM (HR&A) and others all attached with Pichhaboni C.C.C inspected the premises of Sri Sudip Patra (User) residing at Uttar Kadua after maintaining all formalities. During inspection it was found that Sri Sudip Patra (User) is using electricity by means of direct hooking from nearby LTOH line, causing loss of revenue of WBSEDCL.

Therefore, as theft of electricity was detected in the manner of U/S- 135(i) (a) of electricity act 2003 and amendment Act 2007. The purpose of using electricity was domestic with detected load of 0.96 KVA. The unauthorized line was disconnected and removed at site.

Some portion of flat type aluminum wire black in colour along with hooking device of length 4.5 feet approx were seized in the presence of witness and signature are also obtained in the seizure list then packed sealed and labeled at the site of occurrence.

The inspection team then left aforesaid premises on completion of inspection at about 11.50 a.m. on 16/02/2017.

Therefore you are requested to take cognizance of this complain and treat it as FIR.
