In producing herewith the arrested accused persons namely I. Hagrui Bhui (40) s/o Sambhu Bhui, 2. Bine Bhui (37) s/o Ananta Bhui, both of Kismath Thiar, PS-Ramnagar, Dist-Purba Medinipur along with 40 Ltrs ID Liquor with 02 plastic Jerikan containing 20 Ltrs each I also took 02 (two) bottle 600ml ID Liquor taken out as sample. I PSI Mukul Mallick of Ramnagar PS do hereby lodge complaint against the above noted arrested accused persons to the effect that on 29.03.17 at 21.25 hrs, I along with ASI Debasis Bose & C/307 Tapas Kumar Mondal, both of Ramnagar PS left for mobile duty at PS area in course of evening mobile duty vide Ramnagar PS GDE No. 1589, dt. 29.03.17. During mobile duty on 29.03.17 at about 22.25 hrs we found that the above noted accused persons are selling liquors to the different customers at Kismath Thiar from open land under Ramnagar PS. On seeing Police they tried to run away but we managed to apprehend the above mentioned accused persons who were selling liquors to different customers. On ask, they disclosed their name in above noted. On search we found noted liquors in open land. On enquiry, it could be learnt that they were conducting the business of selling off without any licenses since long. On demand they failed to produce any license for possessing / selling of the liquors and any paper regarding possession of such quantity of liquors.
