- ii) Roni Anantamohanmishra (User ID- 100009005456387, Account ID-100009005456387, 270- Exhibit 2, Enclosed)

The undersigned (myself) did not have any such account but this one's had been noted by some of his friends and well-wishers recently.

As a result, efforts have been initiated to identify the name of the person(s) involved with this activities but failed owing to lack of technical knowledge' password etc.

As such accounts have not been created by the undersigned and as there is no scope to open such accounts in absence of the password used to open such accounts, it is not possible for him to deactivate these accounts from his side.

From the information/ data transacted through these accounts it is observed that such accounts have been opened with a definite ill-motive to malign the undersigned and, therefore, utmost request is tendered to your good office to deactivate these accounts immediately.

Further, he also requests to your good office to lodge an FIR against the person(s) involved with this crime and intimate his/their name(s), so that a strong legal action could be taken. With regards,
