Sir,

In producing herewith the arrested accused person namely Rajib Patra (24 yrs) S/O Gopal Patra of Asti, PS. Egra, Dist. Purba Medinipur along with 07 (Seven) bottles Country Spirit each 600ml and ID liquor 40 (Forty) Ltrs. with Two Plastic Jarikan I, ASI Nandadulal Mahakul of Ramnagar PS do hereby lodge complaint against the above noted arrested accused person to the effect that on 13.12.16 at 20:05 hrs I, along with C/1499 Santosh Maity, C/467 Biswanath Naskar, all of Ramnagar PS left for mobile duty vide Ramnagar PS C.C. No. 5917/16 dt. 13.12.16 and GDE No. 542 dt. 13.12.16. During mobile duty on 13.12.16 at 21:05 hrs found that the above noted accused person is selling liquors to the different customers at Depal Hat under Ramnagar PS from his shop. On seeing police he tried to run away but we managed to apprehend the above mentioned accused person who was selling liquors to different customers. On asking, he disclosed his name as above. On search the below noted liquors were found in his shop. On enquiry, it was known that he was conducting the business of selling of liquors without any license since last few days. On demand he failed to produce any license for possessing / selling of the liquors and any paper regarding possession of such quantity of liquors. So, I arrested the above noted accused person on 13.12.16 at 21:15 hrs and seized below noted quantity of liquors from his possession under proper seizure list duly signed by the witnesses on 13.12.16 in between 21:25 hrs to 21:35 hrs.

- 1) Country Spirit each 600 ml. X 07 (Seven) bottles.
- 2) ID liquor 40 (Forty) Ltrs. with Two Plastic Jarikan.

I also took one bottle Country Spirit 600 ml and 01 Ltrs ID liquor from the above-mentioned category as sample.

Since offence has been committed U/S 46A(c) of Bengal Excise Act-1909. So I pray that a specific case may kindly be started against the arrested accused person namely Rajib Patra (24 yrs) S/O Gopal Patra of Asti, PS. Egra, Dist. Purba Medinipur U/S 46A(c) of Bengal Excise Act-1909.
