Sir,

I Anjan Das, son of Sri Dilip Kumar Das, Vill-Nilkuthidanga, PO+PS+Dist-Purulia in the capacity of Inspector Posts, Haldia Sub Division, am to report that on receipt information regarding discrepancy in balance from the Sub Postmaster Kukrahati S.O. ~~the undersigned~~ visited Golapchak Branch post office on 14.2.2017 and on further inquiry it is noticed that Sri Rasamoy Patra son of Late Bansi Badan Patra village + PO- Golapchak PS Sutahata, in the capacity of Gramin Dak Sevak Branch Postmaster Golapchak Branch post office (now under put off duty) was found involved in misappropriation of govt. money in the following accounts standing at Golapchak Branch post office in account with Kukrahati Sub Post Office, the details of which are mentioned below:-

1. SB account no. old (3065333), new(5319658139) standing in name of Kakali Mondal c/o Nikhil Mondal, Vill -Salukkhali, PO-Golapchak

The above mentioned amount has been accepted by said Sri Rasamoy Patra as GDSBPM Golapchak Branch Post office and entered the same in the passbook with office date stamp and initial but the above amount has not been credited in the govt. account by said Sri Patra.

Thus Sri Patra misappropriated govt. money to the extent of Rs 30000/- against the above mentioned account and the defrauded amount in respect of above noted SB account is Rs 30000/-.

2. SB account no old(3066685) new(5319684888) standing in name of Pritikana Gayen vill Parbatipur PO Golapchak

The above mentioned amount has been accepted by said Sri Rasamoy Patra as GDSBPM Golapchak Branch Post office and entered the same in the passbook with office date stamp and initial but the amount has not been credited in the govt. account by said Sri Patra.

Thus Sri Patra misappropriated govt. money to the extent of Rs 29000/- against the above mentioned account and the defrauded amount in respect of above noted SB account is Rs 29000/-.

3. SB account no old (3069770) new (5319754796) standing in name of Suvankar Hazra, s/o Ramprasad Hazra, village- Horekhal, PO - Golapchak.

The above mentioned amount have been accepted by said Sri Rasamoy Patra as GDSBPM Golapchak Branch Post office and entered the same in the passbook and authenticated the same with office date stamp and initial but the above amount have not been credited in the govt. account by said Sri Patra.



Thus Sri Patra misappropriated govt. money to the extent of Rs 20000/- against the above mentioned account and the defrauded amount in respect of above noted SB account is Rs 20000/- from this account.

Therefore, it is alleged that the said Sri Rasamoy, Patra misappropriated govt money to the extent of Rs (30000/- + 29000/-+20000) = Total Rs. 79000/- (Seventy nine thousand only) against the SB account no old(3065333) new(5319658139) , SB account no old(3066685) new(5319684888) & SB account no old(3069770), new(5319754796) respectively .

On considering the pros and coin of the circumstances which has thus arisen and simultaneously tarnished the image of the Department before public you are requested to treat my complaint as F.I.R and take the matter on top most urgent to exercise severe investigation in the case taking cognizance of the fact, thus happened and narrated above and take suitable lawful action against the accused as to be deemed fit.
