Sir,

I, A.S.I. Bidyut Kr. Dhua of Sutahata P.S. Dist. Purba Medinipur do hereby lodge a complaint against the accused Chanchal Mallick (45) S/O Gurupada Mallick of Begunaberia, PS. Sutahata Dist. Purba Medinipur along with seized article i.e. 05 Ltrs. I/D Liquor (Chullu) value approx 250/- which is seized from his house cum shop at Begunaberia under Sutahata P.S. to the effect that on 28.03.17 I, Bidyut Kr. Dhua of Sutahata P.S. along with C/1230 Bharat Chalak, C/202 Sek Ch. Naskar at 16:45hrs. vide C.C. No. 715 dt. 28.03.17, vide GDE No.1189 dt. 28.03.17 left special mobile duty at PS area. As per source information I along with force left for Begunaberia village, held raid in the house cum shop of above noted accused person who was selling I/D Liquor (Chullu) at his house cum shop to the local public illegally. Some customers were present there and on seeing the police they fled away from the place and able to arrest the above noted person. We searched his house cum shop in presence of witnesses and seized approx 05 Ltrs. I/D liquor (Chullu) from his house cum shop in a plastic Jeri can in between 18:15hrs. to 18:45hrs. a prepared seizure list also labeled duly signed by the witnesses at P.O. and taken away 375ml I/D Liquor (Chullu) in a bottle as sample from the seized articles. Under the above noted circumstances his act is punishable u/s 46(A) Bengal Excise Act 1909.

So, I pray may kindly be start a specific Case against person namely Chanchal Mallick S/O Gurupada Mallick of Begunaberia, PS. Sutahata, Dist. Purba Medinipur u/s 46(A) Bengal Excise Act 1909 and oblige.
