Dear Sir,

I do hereby lodged a complaint empowered by the Electricity Act 2003 to the effect that Subodh Patla S/o Lt. Bhanutosh Patla , Vill- Gobindapur, Po-Gobindapur + Bajitpur, PS- Sutahata, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated hereunder.

On 18.04.2017 about 04:40 pm L.Goutam Barua, AE & SM, Chaitanyaapur CCC, Purba Medinipur along with Arjun Bera (L.M) and Bholanath Dilley (TSH) of Chaitanyaapur CCC & Other official went to the domestic premises of Subodh Patla S/o Lt. Bhanutosh Patla , Vill- Gobindapur, Po-Gobindapur + Bajitpur, PS- Sutahata, Dist-Purba Medinipur for inspection purpose.

During inspection it was found that Subodh Patla S/o Lt. Bhanutosh Patla bearing consumer ID - 224050763 and Meter No. G282783 was dishonestly consuming electricity by the way of direct hooking from nearby LTOH line through P.V.C wire bypassing the energy meter for domestic purpose at a rate of load 1.76 KVA , for less recording of energy to the energy meter and thereby causing loss of revenue to WBSEDCI.

As the theft of electricity was detected, the service connection was disconnected and removed the unauthorized wire and some portion of hooking wire single core pvc wire 10 mtr approx. of yellow colour along with hooking device & one yellow card having Sl. No. 368939 in the name of Subodh Patla was seized in the presence of witnesses under a memo of seizure list in presence of the witnesses and duly signed by them. The above seized articles were packed and labeled and signature of witnesses also obtained on the label. I also prepared an inspection report at spot duly signed by the witnesses. After completion of inspection we left the spot at 05.00 pm.

Thus the accused that Subodh Patla S/o Lt. Bhanutosh Patla , Vill- Gobindapur, Po-Gobindapur + Bajitpur, PS- Sutahata, Dist-Purba Medinipur has committed offence U/S 135(i)(b) of the Electricity Act 2003 read with Amendment act 2007 in view of theft of electricity.

Under this circumstance you are requested to take cognizance of this complaint & treated the same as F.I.R.
