Dear Sir,

I do hereby lodge a complaint empowered by the Electricity Act 2003 to the effect that (i) Redaoyanui Karim @ Sk. Redowani Karim S/o Lt. Sk. Mujibar Rahman of Vill-Hariballavpur PS- SUTAHATA, Dist-PURBA MEDINIPUR (ii) Sk. Taher Ali S/o Lt. Sk. Samad Ali of Vill-Hariballavpur, PS- SUTAHATA, Dist-PURBA MEDINIPUR have committed theft of Electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated hereunder.

On 19.04.2017 about 01.05 PM I, Goutam Barua, AE & SM, Chaitanyapur CCC, Purba Medinipur along with Bichitra Ranjan Das (OE) and Bholanath Doley (T.S.H) of Chaitanyapur CCC & Other official went to the domestic premises of Redaoyanui Karim @ Sk. Redowani Karim S/o Lt. Sk. Mujibar Rahman of Vill-Hariballavpur PS- SUTAHATA, Dist-PURBA MEDINIPUR.

During inspection it was found that Redaoyanui Karim @ Sk. Redowani Karim S/o Lt. Sk. Mujibar Rahman bearing consumer ID - 200121403 and Meter No. PT345134 was consuming electricity unauthorizedly and dishonestly by the way of direct hooking from the nearest LTOH line by P.V.C. wire for domestic purpose at a time of load 0.9KVA by passing the energy meter for less recording of energy to the energy meter causing loss of revenue of WBSEDCL.

As the theft of electricity was detected during the inspection, the unauthorized wire was removed and the service connection was disconnected and some portion of P.V.C. wire (white & green colour) approx. 5 Mtr with hooking device was seized under a memo of seizure list in the presence of witnesses and their signature is duly obtained in the seizure list. The above seized items were duly packed and labeled at the inspection site and signature of witnesses also obtained on the label. I also prepared the inspection report on spot duly signed by the witnesses. We left the premises at 01.25 pm.

In Second Phase on the same date, we all the above mentioned Inspection Team entered to the premises of Sk. Taher Ali S/o Lt. Sk. Samad Ali of Vill-Hariballavpur, PS- SUTAHATA, Dist-PURBA MEDINIPUR at about 01.30 pm & found that Sk. Taher Ali S/o Lt. Sk. Samad Ali bearing consumer ID - 200100513 and Meter No. OB4485498 was consuming electricity unauthorizedly and dishonestly by the way of direct hooking from the nearest LTOH line by P.V.C. wire for domestic purpose at a time of load 0.9KVA by passing the energy meter for less recording of energy to the energy meter causing loss of revenue of WBSEDCL.

As the theft of electricity was detected during the inspection, the unauthorized wire was removed and disconnected the service connection and some portion of P.V.C. wire (Green colour) approx. 10 Mtr with hooking device was seized under a memo of seizure list in the presence of witnesses and their signature is duly obtained in the seizure list. The above seized items were duly packed and labeled at the inspection site and signature of witnesses also obtained on the label. I also prepared the inspection report on spot duly signed by the witnesses. We left the premises at 01.50 pm.

Thus the that (i) Redaoyanui Karim @ Sk. Redowani Karim S/o Lt. Sk. Mujibar Rahman of Vill-Hariballavpur PS- SUTAHATA, Dist-PURBA MEDINIPUR (ii) Sk. Taher Ali S/o Lt. Sk. Samad Ali of Vill-Hariballavpur, PS- SUTAHATA, Dist-PURBA MEDINIPUR have committed offence U/s 135(i)(b) of the Electricity Act 2003 read with Amendment act 2007.

The both premises are situated site by site at the same village & same Mouza.

Under this circumstance you are requested to take cognizance of this complaint & treated the same as F.I.R in view of theft of electricity.
