Dear Sir,

I do hereby lodged a complaint empowered by the Electricity Act 2003 to the effect that Ghanashyam Maity S/o Lt. Gunadhar Maity, Vill- Chaklarpur, PS- Sutamata, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated hereunder.

On 22.06.2017 about 02.20 pm I, Goutam Barua, AE & SM, Chaitanyapur CCC, Purba Medinipur along with Dibyendu Sekhar Bhunia (D.E & S&LP) of Tamluk Regional Office & J.S Neogi (S.O. S&LP) of Tamluk Region Office and Arjun Bera (L.M) and Bholanath Doley (TSH) of Chaitanyapur CCC & Other official went to the domestic premises of Ghanashyam Maity S/o Lt. Gunadhar Maity, Vill- Chaklarpur, PS- Sutamata, Dist-Purba Medinipur for inspection purpose.

During inspection it was found that Ghanashyam Maity S/o Lt. Gunadhar Maity bearing consumer ID -224034341 and Meter No. L4079826 was dishonestly consuming electricity by the way of cable bypassing by tampering the incoming service cable before entering to the energy meter for domestic purpose at a tune of load 0.59 KVA, for less recording of energy to the energy meter and thereby causing loss of revenue to WBSEDCL.

As the theft of electricity was detected, the service connection was disconnected and removed the tampered portion of service cable 2 core pvc wire 3 mtr approx. of black colour & one yellow card having SL No. 2321427 in the name of Ghanashyam Maity was seized in the presence of witnesses under a memo of seizure list in presence of the witnesses and duly signed by them. The above seized articles were packed and labeled and signature of witnesses also obtained on the label. I also prepared an inspection report at spot duly signed by the witnesses. After completion of inspection we left the spot at 02.50 pm.

Thus the accused Ghanashyam Maity S/o Lt. Gunadhar Maity, Vill- Chaklarpur, PS- Sutamata, Dist-Purba Medinipur has committed offence U/S 135(i)(b) of the Electricity Act 2003 read with Amendment act 2007 in view of theft of electricity.

Under this circumstance you are requested to take cognizance of this complaint & treated the same as F.I.R.
