Sir,

In producing herewith arrested person namely Mukunda Das (32yrs) s/o Lt. Sudhir Ch. Das of Agadoro, PS. Sutahata, Dist. Purba Medinipur along with seized article which was seized from his possession i.e. 10 Ltrs. I/D Liquor (Chullu) value approx Rs. 500/- I, A.S.I. Bidyut Kr. Dhua of Sutahata P.S. along with C/73 Ashim Patra, C/368 Amit Samanta both of Sutahata P.S. at 19:15hrs. left for special raid duty at PS area vide Sutahata PS C.C. No. 1646/17 dt. 27.06.17, vide GDE No. 1670 dt. 27.06.17. On 27.06.17 at 19:25hrs. in course of special raid duty received source information that one person namely Mukunda Das (32yrs) s/o Lt. Sudhir Ch. Das of Agadoro, PS. Sutahata, Dist. Purba Medinipur was selling I/D Liquor (Chullu) at house cum shop at Agadoro village to the local public illegally. After received such information I informed to O/C Sutahata PS about the matter. As per his order myself along with force proceeded to wards Agadoro village. After arrival there at 20:05hrs. found that one person selling I/D Liquor (Chulu) to the local public illegally. We cordon their and intercepted the said person and other fled away. On being interrogation he disclosed his identity as above and confessed his guilt in respect of illegally selling I/D Liquor (Chulu) at said place to the local public and I asked him to produce valid papers/license for sealing ID liquor but he failed to produce any paper. Accordingly I arrested him and 10 Ltrs. I/D liquor (Chulu) seized in between 20:15hrs. to 20:45hrs from his possession which was kept in one plastic jarican value approx Rs. 500/- after prepared proper seizure list also labeled in presence of witness duly signed by them as well as above noted accused person, issued memo of arrest after maintained all formalities, explained him grounds of arrest at P.O. taken away 375ml I/D Liquor (Chulu) in one bottle as sample from the seized articles.

So I pray may kindly be start a specific Case against arrested person namely Mukunda Das (32yrs) s/o Lt. Sudhir Ch. Das of Agadoro, PS. Sutahata, Dist. Purba Medinipur u/s 46(A) Bengal Excise Act 1909 and oblige.
