I, S.I. Amit Deb O/C Sutahata P.S. do here by lodge a complaint Suo-moto to the effect that on 21.01.17 at 21:04hrs. duty officer ASI Arun Kr. Diyasi received telephonic information from a person who disclosed his identity an incident of firing took place at the house of Mahammad Kayem Mallick s/o Reajuddin Mallick of Bijayrampur, P.S. Sutahata, Dist. Purba Medinipur and duty officer diarised the information in P.S. G.D. Book. After that he informed me. On 21.01.17 at 21:06hrs. myself along with and force left P.S. for Bijayrampur to work out the telephonic information with evening mobile officer ASI Dipak Kr. Mishra along with C/1652 Swapan Maity, VP-Kuntal Das vide Sutahata P.S. CC No. 198/17 dt. 21.01.17 and GDE No. 816 dt. 21.01.17 and after arrival there found that the victim lady has already been shifted at Durgachak S.D. Hospital with injury on her body for treatment. On enquiry it came to learnt that the name of victim lady is Karishma Khatun (16 Yrs) D/O Mahammad Kayem Mallick of Bijayrampur, P.S. Sutahata. Myself searched the P.O. thoroughly very carefully and found (1) 1 (one) bullet head at the bedroom on 1<sup>st</sup> floor to the house of Mahammad Kayem Mallick and 1 (one) empty cartridge found on another room at the door step of bathroom. Gun short mark on tiles fitted on the wall of that bed-room. Accordingly I seized those from P.O. in presence of local witnesses after obtained seizure list duly signed by the witnesses also labelled at P.O. It is also observe that some portion of tiles fitted on the wall became destroyed. Then after visiting the P.O. myself proceeded for Durgachak S.D. Hospital and found that injured lady Karishma Khatun (16 Yrs) D/O Mahammad Kayem Mallick of Bijayrampur, P.S. Sutahata was under treatment injury on her chest. Later she has been shifted to Kolkata for better treatment. On asking to the Doctor who has treated her at Durgachak S.D. Hospital he verbally opined that "injury on chest and back side may be due to gun short".

So, under the above I, SI Amit Deb, O/C Sutahata PS do hereby lodge the complaint after returned to P.S. as Suo-moto and start a specific case against unknown person U/S 326/307 I.P.C. & 25/27/35 Arms Act .
