Chinna Bedh (4) Gobinda Bedh (22Yrs) s/o Lt. Sunil Bedh all of village Jhatipahari, P.S. Chatna, Dist. Bankura it is noted here that on 07.02.17 SI Sankar Kr. Das C/162 Biswanath Das, C/1529 Dilip Mondal, CVF-SK Kasem Ali, CVF-SK Mahiuddin left P.S. to perform night mobile duty at P.S. area vide GDE No. 594 dt. 07.02.17 and CC No. 249 dt. 07.02.17 in course of night mobile duty on 08.02.17 at 00:35hrs. SI Sankar Kr. Das received a telephonic information from reliable source that a gang of criminal were assembled at paddy filed nearby Barada Railway station they may be committed any crime against property under this P.S. area he informed to duty officer and O/C Sutahata P.S. about the matter and duty officer diarised the matter in P.S. G.D. vide GDE No. 597 dt, 08.02.17. As per instruction of O/C Sutahata P.S. I SI Tinugopal Pramanik along with C/915 Bikash Guria, C/73 Ashim Patra, CVF-SK Sahanowaz, CVF-SK Shemser Ali left P.S. on 08.02.17 at 00:45hrs to Barada vide CC No. 251 dt. 08.02.17 & GDE No. 598 dt. 08.02.17 to assist him. On 08.02.17 at 01:05hrs. myself along with force arrived at the open paddy filed near Barada Railway station and as shown by the informant myself along with other officer and force gherrao the gang and proceeded towards them by they receiving smell of police they tried to flew away from that place. On hot chasing were able to restrain the above noted persons. On interrogation they disclosed their name and identity which is noted above they stated that SK Sanwar Ali @ Bana called them at this place for committing house dacoity under Dhekua/Kukrahati area. They stated 6/7 persons including they were assembled for committing crime. On search found (1) 1 (One) house breaking iron rod seized from the exclusive possession of arrested namely Raju Bedh (2) 1 (One) Vhogali seized from the exclusive possession of arrested namely Arun Bedh (3) 4 (Four) pieces of Bamboo Lathi from the exclusive possession of arrested namely Sarju Bedh (4) 1(One) piece of iron made katari from the exclusive possession of arrested namely Gobinda Bedh (5) 4 (Four) pieces of empty 60up liquor bottle (6) 10 (Ten) pieces of glass (7) Some pieces of broken bricks seized from P.O. Accordingly I prepared memo of arrest and seizure list also labelled at spot.

On further interrogation they stated different name identity of them and they failed to produce any satisfactory account for presence at the P.O. in dead hours of night. So it is reasonably believe the above persons and their associate who was managed to escape themselves were assembled for committed crime against property. I am to note here due to dead hours of night no local public attended so search and seizure made by me in presence of other police persons and took their signature in seizure list.

Hence I pray that a specific case may kindly be started against [1] Raju Bedh (25Yrs) s/o Lt.
