

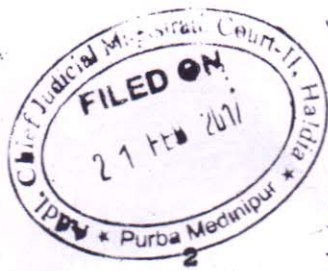

- 1) That the accused no.-1 entered into an agreement with your petitioner for purchasing 06 dec. alongwith ~~taxi~~ tiled house in stead of ₹ 6,00,000/- Under Mouza.- Satahata, Plot No. 115.9.99.160 on 3.5.2015 and he gave ₹ 3,00,000/- in two instalment
 - 2) That ^{after} making agreement the accused no.-1 created pressure for leaving the house.
 - 3) That as the accused no.-1 did not give rest money and do not arrange for registration the petitioner did not leave the ho use and land.
 - 4) That the accused no.-1 did not agree to give rest money but threatned me for leaving the house. But the complainant refused his proposal and made complaint to village committee but the accused no.-1 did not listen to their advice.
 - 5) That the complainant has no source of income and by hard pecuniary way healong with his wife spent their lively hood with the help of son in law.
 - 6) That on the date of occurrence inspite of objection the accused persons took tamarind from ~~tree~~ and being protest they assault ~~me~~ by fist and blow.
 - 7) That the son in law under my instruction diarised the matter.
 - 8) That knowing the fact of diary ~~in the~~ accused persons at about 2.30 p.m. forcibly took fishes about 10 kg. by neting from plot no.-1160 and entering into house ran sacked articles and threatned with out rest money if the petitioner did not make registry they will evict me and ~~as a~~ result the complainant sustained a loss of ₹ 4,25,000 and went to diarise the matter but the police did not diarise.
- The son in law informed the matter to S.P.
- 9) That still now no case has been lodged and by the illegal act they have committed offence U/S. 379/380/406/323 I.P.C.
