I do hereby lodged a complaint empowered by the Electricity Act 2003 to the effect that Gurupada Dolai S/o Lt. Anath Dolai, Vill- Baisnabchak, PS- Sutahata, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated hereunder.

On 09.12.2016 about 11.25am T, Dibyendu Sekhar Bhunia, DE & S&LP, Tamluk Regional office along with Goutam Barua, AE & SM, Chaitanyapur CCC, Purba Medinipur, Arjun Bera (L.M) and Bholanath Duley (T.S.H) of Chaitanyapur CCC & Other official went to the domestic premises of Gurupada Dolai S/o Lt. Anath Dolai, Vill-Baisnabchak, PS- Sutahata, Dist-Purba Medinipur for inspection purpose.

During inspection it was found that Gurupada Dolai S/o Lt. Anath Dolai bearing consumer ID - 224044159 and Meter No. L4067497 was dishonestly consuming electricity by the way of direct hooking from nearby LTOH line through P.V.C wire bypassing the meter for domestic purpose at a tune of load 0.59 KVA, for less recording of energy to the energy meter and thereby causing loss of revenue to WBSEDCL.

As the theft of electricity was detected, the service connection was disconnected and removed the unauthorized wire and some portion of hooking wire single core pvc wire 2 mtr. approx black colour along with hooking device & one yellow card having SL No. 860457 in the name of Gurupada Dolai was seized in the presence of witnesses under a memo of seizure list in presence of the witnesses and duly signed by them. The above seized articles were packed and labeled and signature of witnesses also obtained on the label. I also prepared an inspection report at spot duly signed by the witnesses. After completion of inspection we left the spot at 11.55 am.

Thus the accused that Gurupada Dolai S/o Lt. Anath Dolai, Vill- Baisnabchak, PS- Sutahata, Dist-Purba Medinipur has committed offence U/S 135/(i)(b) of the Electricity Act 2003 read with Amendment act 2007 in view of theft of electricity.

Under this circumstance you are requested to take cognizance of this complaint & treated the same as F.I.R.
