Sir,

In producing herewith arrested accused person namely Rabindranath Ghorai aged 45 yrs s/o Madhab Ghorai of Prasadchak, P.S.- Tamuk, Dist- Purba Medinipur along with the seized articles (i) ten liters I/D liquor in a plastic jaricane containing 10 liters and cost of Rs. 600/- under proper seizure list. I ASI Sankar Mondal of Tamluk P.S. do hereby lodged complaint to the effect that on 21.02.2017 at 14.05 hrs. myself along with officer and C/750, Jayanta Patra, C/448, Asish Roy, I/C 545 Tuhina Das (Dutta) left P.S. to perform evening mobile duty vide Tamluk P.S. G.D.E. no. 1176 dated 21.02.2017 and C.C. no 743 dated 21.02.17. In course of evening mobile duty at 19.45 hrs at Kaktiya received information from my reliable source that one person selling I/D liquor illegally at Kaktiya Bazar from his Stationary Shop. I contacted with two passersby namely (i) Sk. Hasan S/O- Sk. Abu Hossan of Bar Padumbasan, PS- Tamluk, Dist, Purba Medinipur and (ii) Sk. Maidul Islam S/O- Lt. Sk. Guljar of Padumbasan, PS- Tamluk, Dist- Purba Medinipur and request them to assist police and they agreed. We held raid at that Stationary Shop as identified by my source and apprehended the I/D liquor seller in presence of witnesses as noted above. Search was made at the Stationery Shop in presence of apprehended person, above noted witnesses and police party and found I/D liquor kept in a plastic jaricane containing 10 liters and cost of Rs. 600/-. Being asked the apprehended person disclosed his identity as Rabindranath Ghorai aged 45 yrs s/o Madhab Ghorai of Prasadchak, P.S.- Tamuk, Dist- Purba Medinipur and on demand he fails to produce any valid license, papers, documents or challan for posses and sells I/D liquor to publics. I seized (i) ten liters I/D liquor in a plastic jaricane cost of Rs. 600/- kept on the wooden rack after preparing proper seizure list duly signed by the above noted witnesses and as well as the apprehended person. I took sample 01 liters I/D liquor from seized article in a plastic bottle as sample and labeled it also. I arrested the apprehend person Rabindranath Ghorai, issued memo of arrest and informed him ground of arrest. During local enquiry it is crystal clear that Rabindranath Ghorai illegally posses and sells I/D liquor to publics.

Hence, I pray a cog case may kindly be started against accused Rabindranath Ghorai aged 45 yrs s/o Madhab Ghorai of Prasadchak, P.S.- Tamuk, Dist- Purba Medinipur under proper section of law.
