I, S.I Samir Kr. Aich of Tamruk P.S. do hereby lodged complaint to the effect that

today myself along with SI Swapan Chabri O/C Tamruk PS, SI Satya Charan Adhikary, ASI Shib Charan Singh, ASI Sankar Mondal, ASI Bishnupada Panda, 2 others all of Tamruk PS vide CC no 985/17 dated 09/03/17, ASI (AB) Dulal Nandi, ASI (AB) Samir Bhowmick, 23 others vide MCC no 733/17 dated 09/03/17, and 1 LC of Nandakumar PS vide CCno 529 dated 09/03/17, 1 LC of Moyna PS vide CC no 645 dated 09/03/17, 1 LC of Chandipur PS vide CC no 886 dated 09/03/17 1 LC of Kolaghat PS vide CC no 1016 dated 09/03/17 have detailed to perform duty for maintenance of law and order duty of a political program of SUCI party termed as law and violation at D.M office, Purba Medinipur at Tamruk under supervision of Sri Tanmoy Sarkar, SDPO, Tamruk, Shri Sambhunath Bhattacharjee, Dy.S.P., DIB, Purba Medinipur, Shri Biswajit Halder, CI Tamruk and Shri Sajal Das, Executive Magistrate, DM office Purba Medinipur was also present there to guide police during the said duty. At about 15:30 hrs. we found that about 300 male and female supporters of SUCI party along with party flags, banners etc were coming towards DM office by shouting their slogans.

As per our pre arrangement we requested them to stop about 50 meters away from the main gate of DM building and also requested them to carry out their agitation program peacefully without hampering free flow of traffic, ingress and egress main gate of DM office. The Executive Magistrate present there also requested them to maintain peace and to carry their agitation program peacefully. But suddenly the SUCI supporters became violent and started pushing our barricades & tried to enter into the DM office by over powering police personnel on duty. We asked them in loud speaker not to push the deployed officers and forces but they did not listen on our words and continue to push us and suddenly agitated mobs started charging lathi upon us which was brought by them for carrying flags and also started pelting pieces of bricks upon police personnel. As a result some of us police personnel namely C/1534 Mohan Murmu, C/566 Sandip Chakraborty received injuries on their persons. We again warned them by loud speaker but they did not listen on our words and continued in their such activities of violence. Finally no other alternative we used minimum force against the said furious mobs under guidance and supervision of on duty Executive Magistrate and senior police officers present on duty and manage to dispersed the agitated mobs in front the area near DM office. After dispersed of the mob I searched in and around the place and found (i) Three

nos of red colour SUCI flags (ii) 4 nos of lathi (ii) some pieces of bricks and I seized the same after preparing proper seizure list duly signed by the witnesses. Injured police personnel at the spot sent to District hospital Tamluk for medical treatment. Under the above, I pray a cog case may kindly be started against the unruly violent mobs consisting 300 app;rox. of SUC I supporters.
